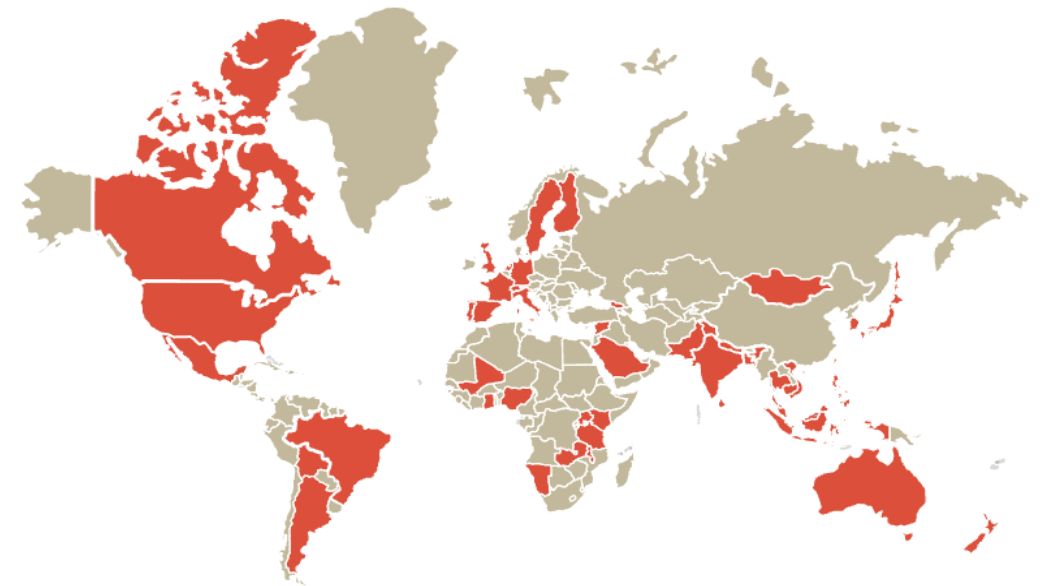


Welcome to the Orange Movement™
